TERMS AND CONDITIONS

Decagon Devices, Inc. agrees to lend factory-owned equipment to the person/company at the address on this agreement form. Offer is only valid in the United States.

Time and Condition Limitations: The equipment can be used for ten (10) business days. At the end of the two weeks, you shall return the equipment in like-new condition to Decagon. If you place a new equipment order for items listed on this agreement, you can keep the items until you receive your new equipment. The demo equipment must be returned within five (5) business days from the receipt of your new equipment.

Location: The demonstration equipment must remain with the person/company listed in this document unless other arrangements have been made with Decagon in writing. Sending the equipment elsewhere may result in charges being collected for the retail price of the items.

Late Charges: After a five (5) day grace period for return of the equipment, rental fees will be assessed and invoiced monthly to the recipient of the equipment until the equipment is received at Decagon. The total invoiced amount shall not exceed the retail price of the equipment. In the case that the full price of the instrument has been invoiced and paid, ownership of the demonstration unit will transfer to the recipient listed on this form.

Shipping Charges: This demonstration service is provided at no charge to you and the item(s) has/have been shipped to you at Decagon's expense. The cost of returning demo equipment to Decagon is the responsibility of the equipment recipient.

Repairs: Any damages incurred to the equipment beyond normal wear and tear will be repaired and invoiced at our normal service rates. If you have questions about the current service rate, please ask a sales or support representative.
